**FAILURE TO COMPLY WITH ONE OF THE ABOVE OPTIONS WILL SUBJECT YOU TO FOLLOWING CONSEQUENCES:**

1. THE PENALTY WILL BE INCREASED AND ADDITIONAL COSTS AND FEES MAY BE IMPOSED; AND/OR
2. YOUR VEHICLE MAY BE SUBJECT TO IMPOUNDMENT: AND/OR
3. THE DEPARTMENT OF MOTOR VEHICLES MAY WITHHOLD THE RENEWAL OF YOUR VEHICLE REGISTRATION; AND/OR
4. A CIVIL JUDGEMENT WILL BE SOUGHT AGAINST YOU FOR THE AMOUNT OF THE PENALTY AND RELATED (ADDITIONAL) COSTS.
