No fax or email copies will be accepted. Submittals received after the specified time and date will not be considered and will be returned unopened to the sender. THIS SUBMISSION DEADLINE WILL BE STRICTLY ENFORCED.

Item #6 – Revision: Page 13, “4.2.4 Submittal Organization”:

Replace paragraph with the following verbiage:

Submit one (1) binder clearly marked “Original,” seven (7) duplicate hard copies of the Submittal, one (1) electronic copy of the submittal in PDF format on a thumb drive, and one separate sealed original Financial document marked “Confidential Financial Information” to City Clerk, attention Jelene de Melo, at the address noted in Section 3.10, prior to the Due Date and Time.

Item #7 – Revision: Page 66, “Exhibit E1: Identification of D-BE Submittal Manager”:

Replace paragraph with the following verbiage:

Note: Any substitution of D-BE’s Submittal Manager during the RSOQ and RFP process shall be made in writing to and approved by the City and shall subject the D-BE to re-evaluation. Submit a written request for substitution to the person indicated below.
