### WELL NO. 16 TEST WELL

1. This Addendum forms a part of the Bidding Documents and will be incorporated into the Contract Documents, as applicable. All other conditions of the Contract Documents remain unchanged. The following changes, additions, or deletions as set forth herein shall apply to the Contract Documents and shall be made a part thereof and shall be subject to all the requirements thereof as through originally shown and/or specified.
2. Bids shall be submitted in accordance with this Addendum. All Bidders MUST acknowledge receipt of this Addendum by signing and returning this Addendum with your bid.

#### Revisions to Plans and Specifications

The deletions or **modifications** shown below and in ATTACHMENT 1 shall become part of the Contract Documents.

**Item No. 1: See Changes to Specification Section 33 21 00 – Well 16 Casing Hammer Test Hold Drilling and Sampling:**

#### 3.6 DISPOSAL OF SURPLUS DRILLING FLUID AND CUTTINGS

- A. The Contractor shall dispose of the surplus drilling fluid and cuttings in a manner acceptable to the Owner. Drill cuttings shall be maintained in a confined area **and then transported and disposed of at the City's Airport disposal site. See Attachment 1 for disposal site location map. and be spread evenly by the Contractor at the completion of the Project in a manner that does not create any mounds or humps greater than six (6) inches above existing ground space. The drilling fluid and excess water from the water sampling shall be retained on-site and allowed to percolate at the drilling site.**

**Item No. 2: See Changes to Specification Section 33 21 00 – Well 16 Casing Hammer Test Hold Drilling and Sampling:**

#### 3.8 CLEANUP

- A. Following completion of the well sealing, the Contractor shall cut off the casing ~~six feet five feet~~ below ground surface and fill the excavation to the original grade.

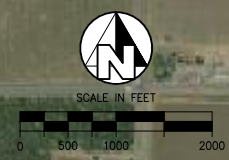
