1. This Addendum forms a part of the Bidding Documents and will be incorporated into the Contract Documents, as applicable. All other conditions of the Contract Documents remain unchanged. The following changes, additions, or deletions as set forth herein shall apply to the Contract Documents and shall be made a part thereof and shall be subject to all the requirements thereof as though originally shown and/or specified.
2. The Contract Documents are hereby modified to affect the following changes:
 - a. The bid opening date has been changed to 2:00 p.m. on **September 6, 2022** in order to complete a soil analysis on existing soils. A copy of the analysis results will be provided in a subsequent addendum. Replace the first paragraph of Advertisement for Bids sheet 1/2 with the following paragraph to extend the bid opening date: "Notice is hereby given that separate sealed bids for the award of contract for the **Construction of FAIRGROUNDS AREA WATERLINE** will be received by the City of Los Banos at the office of the City Clerk until 2:00 p.m. Pacific Daylight Time, **September 6, 2022** and then at said office publicly opened and read aloud."
 - b. Replace the first paragraph of Information to Bidders sheet 1/5 with the following paragraph to extend the bid opening date: "Sealed bids will be received by the City of Los Banos (herein called the "Owner"), at the office of the City Clerk until 2:00 p.m. Pacific Daylight Time (PDT), **September 6, 2022**, then at said office, publicly opened and read aloud. Owner shall reject all bids received after the specified time and will return such bids to bidder, unopened. Bidders must submit bids in accordance with these instructions. No emailed or faxed bids will be accepted."
 - c. Replace the fifth paragraph of the Pre-Bid Meeting section of Information for Bidders sheet 3/5 and the proposed timeline of events associated with the awarding of bid.

“Requests for clarification or questions shall be delivered to the Owner before 5:00 p.m. PDT on **August 23, 2022**. Any Owner response to a request for clarification, questions and answers will be posted to the City’s website at www.losbanos.org no later than 5:00 p.m. PDT on **August 30, 2022** and if necessary, shall become a part of the bid as an addendum.”
