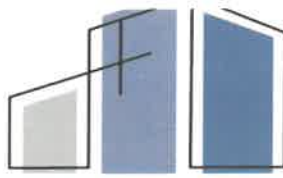

Response: Correct, the stucco was an error. The plank type siding will be painted throughout the facility, as well as the painted doors, downspouts and metal gates. The block shall not be painted.

2. The Windows & Window Frames call to be painted, at the job walk you said no. Please clarify.

Response: The red windows and frames are not to be painted.

3. Please confirm rooftops will be included in painting.

Response: The rooftops shall not be painted.

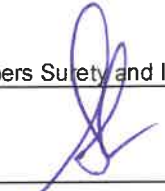

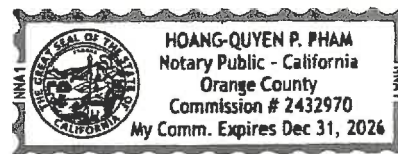

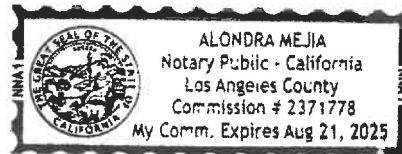
